**Resolution:** The following resolution was proposed and seconded.

**Resolution**

**Whereas,** the primary purpose of the Fourth Degree membership is to foster the spirit of patriotism in members and the community at large and encourage active Catholic citizenship.

**Whereas,** The membership of the Fourth Degree in most cases is made up of active Third Degree members who take part in all the fund raising activities in their respective Councils.

**Whereas,** the funds raised by Fourth Degree members in their respective Councils stays in the Councils, no part of the funds collected are transferred to the Fourth Degree Assemblies.

**Whereas,** The Fourth Degree does not have a fund raising activity, (such as the Ohio Charities Campaign) to take part in the charitable programs, and

**Whereas,** the membership in the Fourth Degree are asked to carry the burden of the Charitable programs twice, once thru their efforts to raise money in their respective Councils and once again in their Assemblies.

**Resolved,** the Assembly shall not make any additional monetary contribution(s) to any charities program or campaign which is funded primarily at the Council level, or by a Chapter or similar association of Councils.

In explanation of how the resolution came about the following information was provided.

Discussion

This resolution is being done instead of an amendment to the by-laws. Everyone needs to understand that the Assembly is not a fund-raising organization like our Council's. And if you read my article you know what the 4<sup>th</sup> Degree was founded for. Council's have specific programs that Supreme and State run, then the Chapter also has programs. Along with these programs are some easy fund raising opportunities that the Assemblies do not have access to. Just to be clear, we are not changing any of the tenets of the Knights of Columbus, we are not second guessing Supreme on their ideals of Charitable acts. The only thing we are saying is that

our Assembly will not participate in any program that is affiliated with a Council activity.

What the resolution does not prohibit is going out and finding a charity to call our own. If, for example, we decided to help out the Mil-Vets organization (They put on the Veteran's Day parade and help families/Dependants of Military personnel) with a donation, we can. This would be a 4<sup>th</sup> Degree function only ... and any fund raiser we did would benefit the Assembly and that charity.

After the resolution was made and seconded discussion occurred. Comparisons were made to Chapter and how it handles requests for contributions. The Chapter view itself as a guiding and directing organization and not itself a fund raising organization. It was pointed out that the Assembly has the ability to vote down any requests for contributions so the resolution may be unnecessary and prevent us from contributing to causes when we do have the resources. It was noted that experiences in past Assemblies showed that many times people fail to consider the fiscal implications of requests and this can result in overburdening the Assembly or pushing them into the red.

It was expressed that the resolution may tie the hands of future Navigators and prevents them from participating in charities that the Assembly wants to participate in. It was further expressed that if a future Navigator wished to they could create a resolution to dissolve the current one. The question was call and the resolution was passed.

**Report of the Third Degree:** 5253 participated in the Tomato festival and raised \$2-\$3,000. On the 30<sup>th</sup> there will be a 2<sup>nd</sup> and 3<sup>rd</sup> degree in Grove City.

**Fourth Degree Team:** There is a meeting on the 27<sup>th</sup> of Sept. to discuss the creation of a 4<sup>th</sup> degree team.


