His widow and Family expressed their sincere thanks for our support.

I attended a **VA Volunteer Services** representatives meeting last month at the Chalmers P. Wylie clinic. The Director reported the target date, even with the four week delay, for the opening of the new Clinic at the Defense Supply Center Columbus is 4 July 2008. There is a proposal to convert the new clinic into an eighty (80) bed hospital. The proposal is five years out, however the new clinic's support foundation has been designed to expand the facility by adding an additional 2 floors. There is also a 5 year funding proposal to expand the Zanesville and Newark clinics. Please continue actively support our VAVS funding program of collecting used cell phones and ink jet cartridges.

During the Saturday afternoon Mass on March 24, Sir Knight Norbert Smithberger accompanied by myself and fellow members of the Assembly Honor Guard presented a new memorial Chalice to Sister Diane Mack, Manager of the Villas at Saint Therese. Sister Diane thanked the Assembly for the generous gift and presented the chalice to Msgr, Robert L. Noon, celebrant for the 4pm Saturday Mass. Norbert Smithberger said he will long remember this event and dedicated this activity in memory of his deceased wife Rita.

**Unfinished Business:**

**Memorial:** The Stone is available. The Memorial Bronze plaque and name tags have all been received. Father Klima would like a drawing of where we wanted it and requested that we wait until spring for installation. The Faithful Navigator showed the 2 proposed areas to the assembly. The Assembly recommended an option with the Assembly store across the sidewalk from the Council stone. As the 2<sup>nd</sup> option they selected having the stones side by side. The Faithful Navigator will discuss with Fr. Klima and once approved start arrangements for the footer to be poured. The footer will need to be at least 4 inch concrete and should be slightly smaller than the stone so as to not be visible.
