





QUALIFICATION GUIDE

Any candidate for the Fourth Degree must be a paid-up member of the Third Degree in good standing, and must have been a member of the Order for at least 1 year. Third Degree Members of the Order for six months or more (but less than 1 year) may apply in writing to the Master for a waiver. The Master will forward the request to the Supreme Master for approval. The waiver request must contain the necessary information, and must be received 3 weeks prior in order to allow time for processing. There is no guarantee that any waiver requests received after that date would be honored.

Business Meeting Minutes

Meeting opened at: 7:35 pm

Roll of Officers: Faithful Admiral, Inner Sentinel and 1 year

Trustee were excused. All other officers were present.

Reading of the minutes: A motion was made to approve the minutes as published. The motion was seconded and passed.

Faithful Friar's Report: The Faithful Friar Passed around a pamphlet about a member of a congregation at his brothers' church and how welcome she felt coming back to the church. He then showed a short video about the mysteries of the Rosary.

Faithful Navigator Report: The Faithful Navigator expressed a word of thanks and Gods Blessing for ALL the officers and members who support the Assembly this year. He felt we had a very successful year and is looking forward to working with our newly elected officers in the coming year.

The Faithful Navigator has prepared a report of officers and after the Faithful Comptroller signs them this evening they will be mailed as required. Next Month we will perform the annual audit following the Assembly Meeting.

Kevin Donoghue and the Faithful Navigator have been actively supporting the VAVS Program at the Chalmers P. Wylie Clinic. They attended the June Quarterly VAVS meeting and filed the required Supreme VAVS report with our Master. The meeting lasted about 1 1/2 hours. They are in the process of trying to purchase another van but are having trouble finding a van driver that can pass the physical. They also talked about the new hospital which will be about 4 or 5 years down the road. Currently they have a roving bed contract with the local hospitals so that beds will be available wherever they need them. Last Friday, 8 June, the Faithful Navigator spent the day cooking Burgers and hot dogs while assisting over 450 area veterans at the clinic annual cook out. There was a lot of good press there and people were appreciative. We received permission to put a collection box at the clinic for Cell phones and ink cartridges. Our Assembly and the Knight of Columbus involvement was recognized and welcome by area Veterans Organization and Clinic employees as a valuable asset and very much appreciated.

The District 3 Masters Meeting was on Sunday June 10th, at the Zanesville Council Hall. It was very informative and well attended. An AD book rebate program was purposed to reward those Assemblies who support the District by Selling Ads for the Exemplification Ad Books. The program runs per Fraternal Year and includes both the fall and Spring Exemplifications. It is comprised of three basic parts, The Buy In, Rebates based upon number of Ads sold, and Rebate Bonuses based upon Dollar value of Ads sold. If this proposal had been in place for the last Exemplification our Assembly would have had a net rebate of \$1005.00. Additionally all attendee's reviewed the Official Formal Dress in full Regalia for Honor Guard and Color Corps as Approved by George L. Mallison Vice Supreme Master of the Fr. Hennepin on April 25, 2007. The new 4th degree Provincial Training manual was available and used during break out sessions as well. These documents can be found on the Master's web site or the Provincial Web Site.
